Motion by Crouch, seconded by Vinton to approve the Consent Agenda, Liquor License, 3 Fireworks permits, and Minutes as presented from May 23, 2023. Lake Ohana Market, KKK Enterprises, LLC, Annual Class E Retail Alcohol License; and Fireworks permit for Robert Beebe, 34254 Lambert Ave, Malvern, IA, June 24th rain date June 25th; Robert Beebe, 25020 Barrus RD, Mineola, IA, July 1st rain date July 2nd, Kirby Roenfeld; Ryan Lenagh, 53998 Elrod Rd, Glenwood, IA, July 1. Resolution 23-30

The Mills County Board of Supervisors sitting in session on this 30th day of May 2023 upon recommendation from the Treasurer and as per Senate file 478 and IA Code 445.16 shall abate the taxes, interest and penalties on the following described property and direct the County Treasurer to strike the amount due from the County system:

The Mills County Treasurer recommends that the taxes pertaining to the 2002 Mobile Home, Skyline, Model Winner LTD, Title number 65AA30621, VIN # 9P510430P located at 28046 US Hwy 34, Mills County, Glenwood, IA building on leased land owned by Donald F. & Paula J. Rech Co-Trustees, parcel 073690010200000 be abated. The Mills County Treasurers recommends taxes be abated in the amount of \$1,170.00, penalty \$85.00 and cost \$4.00 for a total of \$1,229.00. The Mobile Home (building on leased land) has been moved to 23538 Quant Road, Larry J. Rech. This parcel number is invalid, and the parcel number is exempt from taxes going forward.
